

## INDOOROOPILLY SHOPPING CENTRE / INDRO SPEND TO PLAY

### Terms and Conditions

1. These terms and conditions apply to entrants to the 'INDRO SPEND TO PLAY' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Shopping Centres Pty Ltd (ABN 13 001 595 955). The address is 322 Moggill Rd, Indooroopilly QLD 4068.
3. This Offer will be conducted at Indooroopilly Shopping Centre, 322 Moggill Road, Indooroopilly QLD 4068, 07 3378 4022 ("Centre").

### ELIGIBILITY

4. This Promotion is only open to residents of QLD and aged 14 years or over who are able to attend the Centre between 11am and 2pm AEST on Saturday 6 June 2026 and Sunday 7 June 2026 to claim their Prize.
5. The following individuals are ineligible to enter the Promotion:
  - a. employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Promotion;
  - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
  - c. any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

### PROMOTION PERIOD

6. This Promotion commences at 11am AEST on Saturday 6 June and ends at 2pm AEST on Sunday 7 June 2026 or until stock runs out (whichever is first) ("Promotion Period").

### HOW TO ENTER

7. To enter this Promotion, eligible individuals must, during the Promotion Period:
  - a. Spend \$150 or more at any participating store at Indooroopilly Shopping Centre during the Offer Period ("Qualifying Spend");
  - b. Present your Qualifying Spend receipts to a staff member to be stamped at the kiosk located on Level 2 outside Myer between 11am – 2pm AEST on Saturday 6 June and Sunday 7 June.
  - c. Upon verification, the participant will be invited to play one game on the claw machine to select a guaranteed prize ball.
  - d. Each prize ball contains a voucher, which the participant will instantly receive.
8. For clarity, the \$150 total spend can be made up of a maximum of two receipts from one or more participating retailers to comprise your Qualifying Spend and to claim by the end of the Offer Period.
9. The following receipts are not accepted as part of this Offer:
  - a. receipts from the purchase of alcohol, tobacco, lottery tickets or gift cards; and

- b. receipts from the purchase of goods or services which have subsequently been refunded before you have completed your claim.
- c. receipts using After Pay, Klarna, Zip Pay or purchases made via a similar service are not accepted as part of this Promotion.

**LIMITS ON ENTRY**

- 10. One entry permitted per eligible person, per day. Each entry must be submitted separately in accordance with these Terms and Conditions.

**PRIZES**

- 11. There will be 250 gifts available for each day of the Offer Period, while stocks last, awarded on a first-in basis.
- 12. Every valid entry receives a prize (while stocks last)

**PRIZE CONDITIONS**

- 15. Prize No. 1-5 is subject to the following conditions:

## **PROOF OF PURCHASE**

16. You must keep your Qualifying Spend itemised receipts as proof of purchase for your claim. Your Qualifying Spend receipts must clearly identify whether the Qualifying Spend was made, the products purchased (of which must be/comprise the Qualifying Spend) and the date of purchase (which must be during the Offer Period, before you claim).
17. If you don't produce the above proof of purchase for your claim when asked, the Promoter may disqualify your claim and you will lose any right to a gift.
18. Proof of purchase must be identical to that provided by you with your claim.
19. If, in the Promoter's opinion, you have shared any proof of purchase with another person, your claim will be invalid and you will lose any right to a gift.

## **GENERAL**

20. You must not:

32. 33. The Promoter reserves the right, at any time, to verify the validity of entries (including contacting participating retailers) and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
34. If this Promotion is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify an entrant engaging in unauthorised intervention or fraud; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.
35. If any dispute arises concerning the conduct of this promotion, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. However, the Promoter's decision is final, and no correspondence will be entered into.

36. Any cost associated with accessing the promotional website is the entrant's responsibility and is dependent on the internet service provider used. 40. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including without limitation:
- a. any technical difficulties or equipment malfunction;
  - b. any theft, unauthorised access or third party interference;
  - c. any entry or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
  - d. any variation in the prize value to that stated in these Terms and Conditions;
  - e. any tax liability incurred by an entrant or winner; or
  - f. use of the prize,

except for any liability which under statute, including under the Non-Excludable Guarantees, cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).

41. This Promotion is in no way sponsored, endorsed or administered by, or associated with any social media platform, including Instagram or Facebook. You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.

## **PRIVACY**

42. In order to conduct this Promotion, the Promoter needs to collect personal information about each entrant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, if required, to Australian regulatory authorities. Participation in the Promotion is conditional on providing this information.

43. By entering, you consent to the Promoter using this information for promotional, marketing, publicity and research purposes, including telephoning the entrant or sending email or SMS messages provided that where required by the *Spam Act 2003* (Cth), the Promoter includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth).
