

INDOOROOPILLY SHOPPING CENTRE / BLACK FRIDAY CATCH & WIN

Terms and Conditions

1. These terms and conditions apply to participants of the 'Black Friday Catch & Win' Centre Offer ("Offer"). Participation in this Offer is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Shopping Centres Pty Ltd (ABN 13 001 595 955). The address is 322 Moggill Rd, Indooroopilly QLD 4068.
3. This Offer will be conducted at Indooroopilly Shopping Centre, 322 Moggill Road, Indooroopilly QLD 4068, 07 3378 4022 ("Centre").

ELIGIBILITY

4. This Promotion is only open to residents of QLD aged 15 years or over who are able to attend the Centre between 11am and 2pm AEST on Friday 28 – Sunday 30 November 2025 to claim the Prize.
5. The following individuals are ineligible to enter the Promotion:
 - a. employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Promotion;
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

6. This Promotion commences at 11am AEST on Friday 28 November 2025 and ends at 2pm AEST on Sunday 30 November 2025 ("Promotion Period").

HOW TO ENTER

7. To enter this Promotion, eligible individuals must, during the Promotion Period:
 - Make a spend in centre at any Indooroopilly Shopping Centre retail store during the Promotion Period.
 - Between the hours of 11am and 2pm Friday 28, Saturday 29 and Sunday 30 November show your receipt at the Catch and Win booth located on Level 2, outside Calvin Klein.
 - Participants will then be asked to place their hand inside the activation slot where they will catch one (1) ball.
 - The instant prize will be determined depending on the numbered ball as labelled on the Catch and Win booth.
8. For clarity, the participating receipt doesn't need to meet a minimum spend requirement, the Participant however needs to be able to show a receipt that is dated and from an Indooroopilly Shopping Centre retail store during the Promotion Period.
9. The following receipts are not accepted as part of this Offer:
 - a. receipts from the purchase of alcohol, tobacco, lottery tickets or gift cards; and

- b. receipts from the purchase of goods or services which have subsequently been refunded before you have completed your claim.
- c. receipts using After Pay, Klarna, Zip Pay or purchases made via a similar service are not accepted as part of this Promotion.

LIMITS ON ENTRY

- 10. One entry permitted per eligible person, per day. Each entry must be submitted separately in accordance with these Terms and Conditions.

PRIZES

- 11. There will be 1,600 prizes available each day of the Promotion Period, while stocks last, awarded on a first-in basis.
- 12. There will be 4,800 prizes available for the entire Promotion Period, while stocks last, awarded on a first-in bases, as follows:

- 13. Successful claimants will receive one (1) of the 1,400 gift types listed above. For avoidance of doubt, successful claimants cannot choose their gift type and if the stock of one (1) gift type is exhausted, a successful claimant will instead receive the gift type that is in stock. The Promoter is not liable if you do not get your preferred gift.

PRIZE CONDITIONS

- 15. Prize No. 1-6 is subject to the following conditions:
 - a. Gift is not redeemable for cash or transferable and must be taken as offered; and

PROOF OF PURCHASE

- 16. You must keep your Qualifying Spend itemised receipt as proof of purchase for your claim. Your

Qualifying Spend receipt must clearly identify whether the Qualifying Spend was made, the products purchased (of which must be/comprise the Qualifying Spend) and the date of purchase (which must be during the Offer Period, before you claim).

17. If you don't produce the above proof of purchase for your claim when asked, the Promoter may disqualify your claim and you will lose any right to a gift.
18. Proof of purchase must be identical to that provided by you with your claim.
19. If, in the Promoter's opinion, you have shared any proof of purchase with another person, your claim will be invalid and you will lose any right to a gift.

GENERAL

32. 33. The Promoter reserves the right, at any time, to verify the validity of entries (including contacting participating retailers) and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
34. If this Promotion is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify an entrant engaging in unauthorised intervention or fraud; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.
35. If any dispute arises concerning the conduct of this promotion, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. However, the Promoter's decision is final, and no correspondence will be entered into.
36. Any cost associated with accessing the promotional website is the entrant's responsibility and is dependent on the internet service provider used. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.

You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.

PRIVACY

41. In order to conduct this Promotion, the Promoter needs to collect personal information about each entrant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, if required, to Australian regulatory authorities.
