Event Conditions

ORGANISER

- 1. These Event Conditions apply to the Black Friday Cinema Childcare ("Event"), provided by Dexus Shopping Centres Pty Ltd ABN 13 001 595 955 of Indooroopilly Shopping Centre 322 Moggill Road, Indooroopilly QLD 4068 ("Organiser") in conjunction with Stay'nPlay ABN 41 110 504 982 of C/-Diagno Level 6, Southport Central Tower Two 5 Lawson St Southport 4215 ("Partner").
- 2. Entry and participation in the Event is subject to these Event Conditions.

ELIGIBILITY

- 3. This Event is for children between the ages of 4-13 who purchased a ticket to the Event.
- 4. All participants under the age of 18 must receive permission from a parent/guardian to participate and will be supervised by Stay'n Play childcare service.

BOOKING

- 7. You must be aged 18 or over to book for the Event.
- 8. Tickets are available at \$5 + booking fee per child under the age of 18 with the \$5 ticket price being donated by the Promoter to the Communify. Payment must be made in full at the time of making the booking.

 ("Booking Website") between 9am AEST Thursday 20 November 2025 and 6pm AEST Friday 28 November 2025. All bookings are subject to availability. Your booking only takes effect when you receive email confirmation of your booking.

- 10. A booking confirmation will be sent via email. All individuals attending the Event must be able to show the written booking confirmation if required when checking in.
- 11. There is a maximum of 150 places available for your booking.

- 16. All Event staff that interact with children at the Event will hold a valid Working with Children Check.

TRANSFERS, CANCELLATION AND REFUNDS

- 17. If you wish to change the time/day of your Event session, you must visit the Booking Website or click the link included in your booking confirmation email at least 24 hours before your session time to reschedule. Rescheduling your booking to an alternative session will be subject to availability.
- 18. If you can no longer attend your session and wish to cancel your booking, you must request through the Humanitix bookings website.
- 19. If you cancel via the booking website with at least 24 hours' notice prior to the Event date, you will be entitled to a refund of the full amount paid for your booking minus booking fees and any costs or expenses incurred directly by the Organiser as a result of such early termination. For avoidance of doubt, any cancellation applies to the entire Event. You will not be entitled to cancel and receive a refund for a portion or part of the Event unless agreed otherwise. For the avoidance of doubt, to the extent permitted by law, if you provide less than 24 hours' notice of cancellation prior to the Event date, you will not be entitled to any refund.

RULES OF ENTRY

- 20. You must arrive at the Event Location at least 20 minutes before your session time and present your ticket/booking confirmation email to Event staff upon arrival. Registrations open 40 minutes prior to the commencement of the cinema session.
- 21. If participants are late, the event session will still commence at the session time. Stay'nPlay staff will be able to assist with late check-ins but may take longer depending on the amount of check-ins. No refunds or partial refunds will be issued for late attendees.
- 22. You, and individuals attending under your booking (including children and companions), must:

- a. comply with all reasonable instructions provided by Event staff and authorised personnel associated with the Event including authorised personnel of the Organiser and Partner/s;
- b. ensure children are toileted prior to parent / carer leaving the cinemas
- c. parent/ career is to visit Event Cinemas and complete the registration form at the registration dish to sign in their child;
- d. ensure that the parent/carer will remain at Indooroopilly Shopping Centre Whilst the session is in progress;
- e. ensure that the parent/ carer must agree to keep their mobile phone on and answer any calls from Stay'nPlay staff member while their child is in their care;
- f. ensure for child safety that each child receives a wristband with the associated stub provided to the parent/carer. The parent/carer is to return with the stub upon collection of their child:
- g. ensure that the same parent/carer who registered the child needs to be the same parent/carer to collect the child.
- h. agree that a First Aid trained Stay'nPlay Team Member to attend to their child in the first instance. Stay'nPlay will contact parent/carer immediately and to escalate to the Indooroopilly Shopping Centre's security team.
- i. agree that disruptive children and those who are a threat to the safety of other children will be removed by the Stay'nPlay staff and the parent/carer will be contacted to collect them.
- j. agree that whilst Stay'nPlay act in the best interests of the children and take all reasonable steps to ensure their safety and wellbeing; however, Stay'nPlay and the Promoter will not be held responsible for any accident or injury sustained during the cinema session supervised by Stay'nPlay.
- k. agree that whilst reasonable care is taken with children's belongings and clothing. Stay'nPlay and the Promoter are not responsible for any loss or damage to children's belongings or clothing.
- 23. You, and any individuals attending under your booking (including children and companions) must not:
 - a. engage in any conduct that may jeopardise the proper conduct of the Event or the health and safety of staff or participants;
 - b. engage in any conduct that may result in physical damage at the Event Location;
 - c. act in a disruptive, annoying, threatening, abusive or harassing manner, or any other manner that is otherwise inappropriate;
 - do anything that may diminish the good name or reputation of the Organiser or Partner/s or any of their respective related entities or of the agencies or companies associated with this Event; or
 - e. breach any laws.
- 24. If you or any individuals attending under your booking (including children and companions) act in the above manner or otherwise materially breach these Event Conditions, you and those individuals may be refused entry or asked to leave the Event Location and be restricted from participating in the Event, in the Organiser's (or its authorised personnel's) reasonable discretion.

If you are making a booking for any minors (being participants under the age of 18), you accept these Event Conditions both on your own behalf and on behalf of the minor/s, as applicable.
- 31. The Partner is a third party which are separate from the Organiser. The Organiser is not responsible for the conduct of the Partner or any other third parties that are otherwise associated with the Event.

CHANGES TO THE EVENT

32. The Organiser may make changes to Event (that do not substantially vary the event).

- 33. The Organiser may reschedule or delay the Event if it determines it is reasonably necessary to do so upon written notice to you.
- 34. If the Event is interfered with or is not capable of being conducted as reasonably anticipated due to events or reasons beyond the reasonable control of the Organiser (for example, due to security or operational reasons, weather conditions, government directives, a pandemic, public health orders and the like), the Organiser may terminate, suspend or cancel the Event in its reasonable discretion, and if practicable, provide you with reasonable notice, in which event, you will not be entitled to a refund of any amount paid for tickets to the Event (if applicable). If the Event is terminated, suspended or cancelled for any other reason by the Organiser, we will refund you the amount paid for the tickets (if applicable) that could not be fulfilled.

LIABILITY

- 35. You may have consumer rights under statute including under the Australian Consumer Law ("ACL") in the *Competition and Consumer Act 2010* (Cth), which may be applicable to the supply and cannot be excluded or restricted. Nothing in these Event Conditions excludes
- 36. To the extent permitted by law, if the Organiser's or Partner's supply of goods or services in connection with the Event or under these Event Conditions is within the meaning prescribed under the ACL, then the Organiser's or Partner's liability (as applicable) for any failure to comply with a statutory guarantee, condition or warranty that cannot be excluded under statute is limited to (at the Organiser's or Partner's choice (as applicable):

- a. in the case of services; the cost of supplying the services again or payment of the cost of having the services supplied again; and
- b. in the case of goods; the cost of replacing the goods, supplying equivalent goods or having the goods repaired, or payment of the cost of replacing the goods, supplying equivalent goods or having the goods repaired.
- 38. To the fullest extent permitted by law, each Party's total liability to the other Party for any loss, liability or damage suffered by that other Party in connection with the Event or these Event Conditions (including under statute, in contract, negligence, or otherwise) is limited to \$1,000, and will be reduced by the extent (if any) to which the other Party causes or contributes to that loss, liability or damage.
- 39. Subject to paragraphs 40 and 41, neither Party will be liable to the other for consequential, indirect, special, incidental, exemplary or economic damage or loss (including loss of use, loss of revenue, loss of profit, business interruption, costs of procurement of substitution of goods, technology or services or loss of information) arising from a breach of these Event Conditions (including any claim in negligence, equity or otherwise).

INTELLECTUAL PROPERTY

- 40. The Organiser is the copyright owner of the material on the Booking Website or is licensed by the copyright owner to use such material on the Booking Website. All trademarks, brands, names and other intellectual property appearing on the Booking Website are the property of their respective owners.
- 41. You are not granted any rights, title or interest in the material on the Booking Website. You must not adapt, reproduce, publish, distribute or transmit any of the material on the Booking Website without the express written consent of the Organiser and any other relevant intellectual property rights owners (as applicable).

MISCELLANEOUS

42. In these Event Conditions, "including" is not a word of limitation.

- 43. The Organiser may assign, novate or otherwise deal with any of its rights or obligations under these Event Conditions without obtaining your consent, if to do so will be unlikely to cause any material detriment to you.
- 44. If any provision of these Event Conditions is unlawful or unenforceable, the remaining provisions will continue in full force and effect.
- 45. These Event Conditions are governed by the laws of Brisbane, Australia and the parties irrevocably submit to the jurisdiction of the courts having jurisdiction in Brisbane, Australia.
