

INDOORROOPILLY SHOPPING CENTRE / 'FUN FOR \$15' OFFER

Terms and Conditions

1. These terms and conditions apply to participants of the 'Fun for \$15' Centre Offer ("Offer"). Participation in this Offer is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Shopping Centres Pty Ltd (ABN 13 001 595 955). The address is 322 Moggill Rd, Indooroopilly QLD 4068.
3. This Offer will be conducted at Indooroopilly Shopping Centre, 322 Moggill Rd, Indooroopilly QLD 4068, 07 3378 4022 ("Centre").

ELIGIBILITY

4. This Offer is only open to residents of QLD who are 14 years or older and are able to attend the centre between 9am AEST on Friday 16 January 2026 and 3:59pm AEST on Sunday 1 February 2026 to claim their 'Fun for \$15' pass/es.
5. The following individuals are ineligible to participate in the Offer:
 - a. employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Offer;
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to participate in the Promoter's offers.

OFFER PERIOD

6. This Offer commences 9am AEST on Friday 16 January 2026 and ends at 3:59pm AEST on Sunday 1 February 2026 or until stocks run out, whichever occurs first. ("Offer Period").
7. 'Fun for \$15' pass/es are available for sale until 3:59pm Sunday 1 February 2026.

HOW TO PURCHASE

8. To purchase, eligible individuals must, during the Offer Period:
 - a. Visit the Indooroopilly Shopping Centre website at www.indooroopillyshopping.com.au and click on the "purchase tickets here" link on the Fun for \$15 landing page. This link will click through to the 'Fun for \$15' Humanitix event page, where Purchasers will be able to login and purchase their passes. 'Fun for \$15' passes are only available for purchase online.
 - b. A confirmation email will be sent to the Purchaser with the purchase details. Present this email with photo ID to the Indooroopilly Shopping Centre information desk on Level 2 during centre operating hours (Monday – Wednesday and Friday 9:00am – 5:30pm, Thursday 9:00am – 9:00pm, Saturday 9:00am – 5:00pm, Sunday 10:00am – 4:00pm) to collect the vouchers included in the Fun For \$15 pass.
9. Once a purchase is made by the Purchaser, the Purchaser acknowledges that the Promoter's decision in relation to any aspect of the 'Fun for \$15' pass is final and binding. Refunds may be requested up to 48 hours before the end of the Offer period. Refunds will not be provided once a 'Fun for \$15' pass has been collected in-centre.

10. Purchases are only open to visitors to Indooroopilly Shopping Centre. All Purchasers must be over 14 years of age to purchase and redeem 'Fun for \$15' pass/es and the Promoter has the right to request proof of age identification to verify the age of the Purchaser, such as a valid and current Driver's License or Passport.
11. The total price of a 'Fun for \$15' pass is \$15 and includes the Humanitix booking fee and GST. All prices of Fun for \$15 pass/es are in Australian dollars.
12. Once the purchase has been made via Humanitix, a validation email will be sent to the Purchaser to confirm the order.

HOW TO COLLECT & REDEEM

13. To redeem 'Fun for \$15' pass/es, the Purchaser must complete the following steps during the Offer Period:
 - a. Present their email confirmation, as provided in Humanitix, with photo ID to a staff member at the Indooroopilly Shopping Centre information desk on Level 2 during Centre operating hours (Monday – Wednesday and Friday 9:00am – 5:30pm, Thursday 9:00am – 9:00pm, Saturday 9:00am – 5:00pm, Sunday 10:00am – 4:00pm) to collect the 'Fun For \$15' pass.
 - b. Indooroopilly Customer Service Team will issue the 'Fun for \$15' pass and mark your order as being collected.
 - c. Fun for \$15 pass/es are valid for redemption at participating retailers from 9am AEST Friday 16 January 2026 until close of trade on Sunday, 1 February 2026. To view participating retailers' trading hours, please visit indooroopillyshopping.com.au/stores. Any unused items at the end of the Offer Period will be void. Customers must retain email confirmation as proof of purchase. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in invalidation of all a customer's passes and forfeiture of any right to vouchers. Receipt(s) must clearly indicate name and the number of passes during the Offer Period.

FUN FOR \$15' VOUCHER CONDITIONS

15. Event Cinemas Indooroopilly movie ticket conditions:

- a. This eVoucher will expire on the date indicated.
- b. This eVoucher entitles the holder to one Adult, Student or Child admission to any Original session at Event Cinemas Indooroopilly only.
- c. Not valid for use at Moonlight Cinemas, Skyline Drive In or Village Cinemas.
- d. Surcharges apply to upgrade to V-Max or 3D screenings and must be paid at the time of redeeming the eVoucher.
- e. 3D glasses sold separately.
- f. This eVoucher cannot be redeemed for Gold Class, Premium Seating concepts, 4DX, Boutique, Event Junior, Movie Marathons, Chicks At The Flicks, group bookings or any sessions classified as festivals, alternate content or special events including but not limited to foreign films.

16. Timezone Indooroopilly Time Play pass conditions:

- a. Each Time Play package is valid for one person to use ONLY.
- b. Sharing of Time Play will result in the forfeit of package inclusions.
- c. Price and inclusions are subject to change.
- d. All games and inclusions must be used in the allocated time.
- e. The allocated time begins after the successful completion of the purchase (the transaction) and the time play package cannot be used at a later date or time in future.
- f. A delay between each successful tap is used to share the fun around.
- g. Powertickets are pre-loaded to your Powercard, additional Powertickets will NOT be awarded during Time Play.
- h. Exclusions apply to some packages.
- i. Time Play packages are subject to availability and may not be available in all venues. Your gameplay credit balance cannot be used during a Time Play package. After the time has lapsed, credit balances will be able to be used.
- j. Timezone reserves the right to change, alter and remove Time Play packs without any notice by publishing the updates to this website.

- k. One voucher per person.
- 17. \$5.00 Food Voucher conditions:
 - a. This voucher is valid for use at participating retailers only.
 - b. Each voucher is for a single transaction only and cannot be reused.
 - c. The full \$5.00 value must be used on one transaction. No change, credit, or partial refunds will be given.
 - d. This voucher is not redeemable for cash, credit or gift cards.
 - e. This voucher cannot be redeemed online and is only valid for in-store purchases.
 - f. Lost, stolen or damaged vouchers will not be replaced.
 - g. This voucher will expire on the date indicated on the physical voucher.
 - h. One voucher per person.

CLAIM LIMITS

- 18. There is a limit of [5] passes per Purchaser per transaction for the entire Offer Period.
- 19. Each claim must be submitted separately in accordance with these Terms and Conditions.
- 20. There are 500 passes available for the entire Offer Period, while stocks last, awarded on a first-in basis.

UNCLAIMED 'FUN FOR \$15' PASSES

- 21. Any 'Fun for \$15' pass/es that have been purchased but remain unclaimed will not be refunded or have the validity date extended.

GENERAL

- 22. You must not:
 - a. tamper with the claim process (including but not limited to manipulating the system via bots, script use, or any other means to circumvent the claim process);
 - b. engage in any conduct that may jeopardise the fair and proper conduct of this Offer;
 - c. act in a disruptive, annoying, threatening, abusive or harassing manner;
 - d. do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this Offer;
 - e. breach any law;
 - f. breach any "community guidelines" issued by the Promoter from time to time, published at www.indooroopillyshopping.com.au; or

27. You must ensure that you/your companion/s are healthy and fit enough to take the activity. You/your companion/s must follow all requirements of the people responsible for managing the relevant activity/ies.
28. If you (or your companion/s, if applicable), in the opinion of the Promoter (and/or a medical professional, as relevant to the circumstances), are intoxicated, under the influence of alcohol or any other drug, behave aggressively or offensively, or behave in a manner which may diminish the good name or reputation of the Promoter or any of its related entities or the agencies or companies associated with this Offer, is contrary to law or is otherwise inappropriate, the Promoter may cancel the voucher or restrict you (and your companion/s) from participating in any elements of the Offer, at its discretion.
29. The Promoter is not responsible for any dispute between you and any person with whom you choose to, or choose not to, share a voucher.
30. If any voucher (or part of any voucher) is unavailable due to reasons beyond the control of the Promoter, the Promoter at its discretion, reserves the right to substitute the voucher (or that part of the voucher) with a gift or part of a gift with an equal or higher value and/or specification, subject to any written directions from a regulatory authority if applicable.
31. 'Fun for \$15' passes, or any unused portion of a voucher, are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified by the Promoter.
32. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting participating retailers) and participants (including a participant's identity, age and place of residence) and to disqualify any participant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
33. If this Offer is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify a participant engaging in unauthorised intervention or fraud; or (b) to modify, suspend, terminate or cancel the Offer, as appropriate and if applicable, subject to any written directions from a regulatory authority.
34. If any dispute arises concerning the conduct of this Offer, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. However, the Promoter's decision is final, and no correspondence will be entered into.
35. Any cost associated with accessing the promotional website is the participant's responsibility and is dependent on the internet service provider used.
36. Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other implied warranties under similar consumer protection laws in the State and Territories of

Australia ("Non-Excludable Guarantees").

37. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Offer, including without limitation:
- a. any technical difficulties or equipment malfunction;
 - b. any theft, unauthorised access or third party interference;
 - c. any claim or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
 - d. any variation in the gift value to that stated in these Terms and Conditions;
 - e. any tax liability incurred by a participant; or
 - f. use of the gift,

except for any liability which under statute, including under the Non-Excludable Guarantees, cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).

38. This Offer is in no way sponsored, endorsed or administered by, or associated with any social media platform, including Instagram or Facebook. You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.

PRIVACY

39. In order to conduct this Offer, the Promoter needs to collect personal information about each participant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, gift suppliers and, if required, to Australian regulatory authorities. Participation in the Offer is conditional on providing this information.
40. By purchasing, you consent to the Promoter using this information for promotional, marketing, publicity and research purposes, including telephoning the participant or sending email or SMS messages provided that where required by the *Spam Act 2003* (Cth), the Promoter includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth). You also consent to receive email or SMS messages from the Promoter without any functional unsubscribe facility if they relate primarily to the conduct of this Offer. If you have marked the "opt-in" box on the claim form relating to a third party collecting your personal information, you consent to the storage of your personal information on the specified third party's database/s and the specified third party may use this information for future promotional and marketing purposes regarding their products and services including contacting you via electronic messaging provided that where required by the *Spam Act 2003* (Cth), the third party includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth). You should contact the relevant third party/ies for their privacy policy/ies.
