ELIGIBILITY

4. Subject to conditions, this Fundraising is only open to Australian residents aged 18 years or over.

FUNDRAISING PERIOD

- **5.** This Fundraising commences at 9:00am Australian Eastern Standard Time ("AEST") on Thursday 30 November 2023 and ends at 11:59pm on Sunday 24 December 2023 AEST ("Fundraising Period").
- **6.** During the Fundraising Period, customers can contribute to 'Gifts of Joy' at Indooroopilly Shopping centre in the following ways:
 - Scan the QR code at the Toy display on level 2, near H&M.
 - Visit the charity gift wrap service on level 3 near Adairs and spend a min \$2 per present wrapped, cash or electronic payment is accepted.
 - Follow the link via the Indooroopilly Shopping Centre website.
- **7.** Customers will be directed to a 'donate now' page on the Children's Hospital Foundation's website to complete their donation.
- 8. All donations to the Toy display over \$2 will be tax deductable and will receive a tax invoice.
- 9. Having gifts wrapped at the charity gift wrap service, will not constitute a tax deduction.
- **10.** The funds raised over the Fundraising Period will be donated to the Children's Hospital Foundation.
- 11. The funds will go towards:
 - a. A curated wish list of items which includes iPads, Lego, Playdoh and colouring in books; and
 - b. Support services for children in the Queensland Children's Hospital.
- 12. The funds will be allocated at the discretion of the Children's Hospital Foundation.

IMPACT REPORTING

- **16.** The Promoter accepts no responsibility for lost, stolen or damaged items occurring during a visit to the charity gift wrap service.
- 17. A maximum of 10 gifts per person per visit will be wrapped by the gift wrap service.
- **18.** During peak periods, the gift wrap service may have long waits. The Promoter accepts no responsibility for carparking fees due to wait times at the service. Customers are encouraged to visit Customer Service on level 2 to validate their parking if they have met the daily \$200 spend threshold.

GENERAL

- 19. If this Fundraising is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion to the fullest extent permitted by law to subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Fundraising, as appropriate.
