

## INDOORROOPILLY SHOPPING CENTRE / CHRISTMAS UBER VOUCHERS

### Terms and Conditions

1. These terms and conditions are for all entrants who enter the 'CHRISTMAS UBER VOUCHERS' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Shopping Centres Pty Ltd (ABN: 13 001 595 955) of Indooroopilly Shopping Centre 322 Moggill Rd, Indooroopilly QLD 4068. Telephone: 07 3378 4022.

### ELIGIBILITY

3. Subject to conditions, this Promotion is only open to Brisbane residents aged 18 years or over.
4. The following are ineligible: (i) employees of the Promoter, Dexus or any of the tenants or retailers in the Participating Centre/s or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

### PROMOTION PERIOD

5. This Promotion commences at 7am Australian Eastern Standard Time ("AEST") on Monday 18 December 2023 and ends at 7pm on Sunday 24 December 2023 AEST or while stocks last. ("Promotion Period"). Vouchers will be able to be redeemed from 9am on Thursday 14 December 2023 AEST.

### HOW TO ENTER

6. To redeem a voucher, eligible individuals must, during the Promotion Period, simply:
  - Visit [www.indooroopillyshopping.com.au/christmas-2023/](http://www.indooroopillyshopping.com.au/christmas-2023/) and click the link to claim an Uber voucher code.
  - Download the Uber app and enter the destination of your trip (either Indooroopilly Shopping Centre or your return trip destination).
  - Click the payment option at the bottom and in the voucher section enter the Uber voucher code provided via the Indooroopilly website.
  - If the total Uber fare is more than \$50 (fifty dollars) the customer will be required to pay the difference.
  - There is a limit of one (1) free ride per eligible customer.
7. It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoter's database and to be used in accordance with the purposes set out in these Terms and Conditions.

### LIMITS ON ENTRY

8. Only 1 (one) Uber ride to the value of \$50, per person during the promotional period may be redeemed.
9. Guests must be 18 years and over to enter.

## **PRIZES**

10. A total of value of \$5,000 of Uber vouchers will be available to be redeemed during the promotional period.
11. Any items part of the promotion are not redeemable for cash or transferable and must be taken as offered.
12. The voucher and/or any element of the prize must be taken as stated and cannot be varied. No compensation will be payable if the winner is unable to use their prize and/or any element of the prize as stated.
13. The Promotion vouchers can only be used for direct or return rides within a 0.4km radius of 322 Moggill Road, Indooroopilly QLD 4068.

## **GENERAL**

14. The 'CHRISTMAS UBER VOUCHERS' promotion will end once all the vouchers have been redeemed.
15. Indooroopilly Shopping Centre reserves the right to ruminare or amend any aspect of this Promotion without notice at any time.
16. Indooroopilly Shopping Centre is not responsible or liable for the Prize winner's inability to claim the Free Ride or Uber Voucher.
17. Indooroopilly Shopping Centre and its related corporate bodies will not be liable for any loss, damage or injury suffered or sustained (including but not limited to direct or consequential loss or loss arising from negligence) arising directly or indirectly out of or in connection with the Promotion or Uber ride.
18. By entering the voucher code into the Uber app, you are deemed to have accepted these Terms and Conditions, as well as Uber's Terms of Use and any of Uber's Terms and Conditions that apply to the Promotion.
19. Incomplete, indecipherable or illegible entries will be deemed invalid.
20. If there is a dispute as to the identity of the entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
21. Prize is subject to the standard terms and conditions of individual prize and service providers. If for any reason a winner does not take the prize or an element of the prize at the time stipulated, then the prize or that element of the prize will be forfeited and will not be redeemable for cash.
