Terms and Conditions

- 1. These terms and conditions apply to participants of the 'Event Day Parking' Centre Offer ("Offer"). Participation in this Offer is deemed acceptance of these Terms and Conditions.
- 2. The "Promoter" is Dexus Shopping Centres Pty Ltd, (ABN 13 001 595 955) of Indooroopilly Shopping Centre, 322 Moggill Road Indooroopilly QLD 4068.

ELIGIBILITY

- 4. This Offer is only open to residents of Australia and New Zealand aged 17 years or over who are able to attend the Centre during the Offer period to claim the Offer.
- 5. The following individuals are ineligible to participate in the Offer:

OFFER PERIOD

THE OFFER

7. Eligible customers who validate their parking are entitled to a flat parking fee of \$5 at the Centre on event days at Suncorp Stadium. Customers must exit the carpark before 4:00am the next day. The offer excludes Valet parking.

CLAIM INSTRUCTIONS

- 8. To make a claim, eligible individuals must complete the following steps during the Offer Period:
 - a. Enter the carpark at the Centre before 5:00pm on the dates listed in Schedule 1 (or 4:00pm on Sundays), when events are hosted at Suncorp Stadium.
 - Visit the Customer Service Desk on Level 2 during trading hours (Monday–Saturday: 9:00am 5:00pm, Sunday: 10:00am 4:00pm).
 - c. Provide a valid ticket for a Suncorp Stadium event on the same date as the claim and their car registration number to validate parking.

d. Pay the flat fee of \$5 prior to exiting the carpark.

GENERAL

9. You must not:

- a. tamper with the claim process (including but not limited to manipulating the system via bots, script use, or any other means to circumvent the claim process);
- b. engage in any conduct that may jeopardise the fair and proper conduct of this Offer;

- 17. Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If this Offer is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify a participant engaging in unauthorised intervention or fraud; or (b) to modify, suspend, terminate or cancel the Offer, as appropriate and if applicable, subject to any written directions from a regulatory authority.

The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Offer, including without limitation:
 - a. any technical difficulties or equipment malfunction;
 - b. any theft, unauthorised access or third party interference;
 - c. any claim or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
 - d. any variation in the gift value to that stated in these Terms and Conditions;
 - e. any tax liability incurred by a participant; or
