Terms & Conditions

1. Information on how to enter, how to claim, and details of the Flicks & Food Pass Promotion ("Promotion") form part of these Terms and Conditions. Participation in this promotion constitutes acceptance of, and an agreement to be bound by, these Terms and Conditions.
2. This Promotion is open to customers and staff members of Indooroopilly Shopping Centre any persons under the age of 18 must have parental/guardian approval to purchase a Flicks & Food Pass and the parent/guardian of the entrant must read and consent to all of these Terms and Conditions of the Promotion.
3. The entrant acknowledges that the Promoter's decision in relation to anything in these Terms and Conditions or any aspect of the Promotion is final and binding.
4. All references to times and dates in these Terms and Conditions are to times and dates according to Queensland time GMT +10 hours.
5. All references in these Terms and Conditions to prices and values of the Flicks & Food Pass include GST and are in Australian Dollars.
6. Unless otherwise indicated in these Terms and Conditions, a reference to a place in these Terms and Conditions is a reference to the relevant place in the Indooroopilly Shopping Centre.
7. The Promotion commences at Indooroopilly Shopping Centre at 9:00am on Tuesday 6 October 2020 and closes at 4:00pm on Sunday 8 November 2020 or while stocks last.
8. Ticket sales commence via eventbrite at 9:00am on Tuesday 6 October 2020 and end 3:00pm Sunday 1 November 2020. Flicks & Food passes are valid to use at participating retailers until 8:00pm Sunday 8 November 2020 (please refer to individual participating retailer's trading hours).
9. Refunds are available by contacting [marketing@indooroopillyshopping.com.au](mailto:marketing@indooroopillyshopping.com.au) or requesting through eventbrite – no refunds will be issued after 4:00pm on 8 November, 2020.
10. Passes cannot be redeemed after 4:00pm on Sunday 8 Nov 2020, any unclaimed passes will not be refunded.
11. Despite any other provision in these Terms and Conditions, the Promoter may extend the Promotion Period at its discretion and without prior notice.
12. How Eligible Customers can purchase and collect their Flicks & Food Pass: Customers can purchase a Flick & Food Pass online with collection of passes in centre at Indooroopilly's Customer Service desk during business hours located on Level 2 near Country Road.
13. Flicks & Food Pass inclusions: Kids passes cost \$15 per child and are available for children aged 13 years and under and include: (i) 1 kids general admission movie ticket to Event Cinemas Indooroopilly;
