

INDOOROOPILLY FREE COMMUNITY EASTER EGG HUNT
TERMS AND CONDITIONS

1. Information on how to vote and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is AMP Capital Shopping Centres Pty Limited (ABN 13 001 595 955) of 33 Alfred Street, Sydney NSW 2000 AUSTRALIA telephone **07 3378 4022** ("**Promoter**").
3. Entry is only open to all Australian residents.
4. Employees (and their immediate families) of the Promoter, [Indooroopilly Shopping Centre], tenants and their employees of the promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
